The Instrument of Government states that the Governing Body shall consist of 19 Governors as follows:

2 Parent Governors / 1 Headteacher / 1 Staff / 1 Local Authority / 10 Co-opted Governors (1 x Vacancy) / 4 Foundation Governors (2 x Vacancies)

* Foundation Governors are appointed by the Diocese of Lincoln Board of Education, the Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.

** All Governors' terms of office are 4 years.

The Governing Body have not appointed any Associate Governors for the Academic Year 2021 - 2022.

The Governing Body appointed 4 Committees in September 2021 – other appeals committees will be appointed as and when required:

Pay – Meets as directed by the ratified Pay Policy

Heads Performance Management Panel – Meets once and makes a recommendation to Pay Committee regarding Headteacher's Pay decision.

Quality and Standards – Meets four times a year

Curriculum and Community - Meets 3 times a year

Resources – Meets 6 times a year

Full Governing Body - Meets 4 times a year

The Full Governing Body ratifies decisions following recommendation from the committees above (unless otherwise stated in School Policy/Terms of Reference/Scheme of Delegation), and all minutes are available upon request from the Clerk to Governors with the exception of confidential minutes.
